## **RESOLUTION 15-03-212-13**

A RESOLUTION MODIFYING RESOLUTION #08-02-29-99 WHICH AUTHORIZED LAND LEASES FOR RESIDENTIAL PURPOSES TO MILLE LACS RESERVATION HOUSING AUTHORITY FOR THE 18 **HOME PROJECT** (Parcel 1-Tract #s 410T000182 & 410T000264)

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe WHEREAS, for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- Resolution #08-02-29-99 which authorized a land lease to the Mille Lacs WHEREAS. Reservation Housing Authority for the purpose of establishing the 18-Home site project; and
- the lease included the lease site described below to be leased for a period of 25 WHEREAS. years and renewable for an additional 25 years, subject to the lease provisions, effective December 4, 1998; and
- the Lease site is described as follows: WHEREAS.

Tract #s 410T000182 & 410T000264 That part of the Southwest Quarter of the Northeast Quarter being part of Indian

allotments 182, 183, and 264, all in Section 2, Township 41 North, Range 17 West, Pine County, Minnesota, in accordance with the re-survey of sections 2, 3, 6, 8, 18 & 30, Township 41 North, Range 17 West, of the 4th Principal Meridian as surveyed for the General land Office by Earl G. Harrington, W.S. Cadastral Engineer from May 27 to August 6, 1924 and filed for record in the Office of the Secretary of State of Minnesota, described as follows:

Commencing at the General Land Office brass cap monument marking the Northeast corner of said Southwest Quarter of the Northeast Quarter, thence North 89 degrees 38 minutes 37 seconds West, assumed bearing 53.94 feet along the North line of said Southwest Quarter of the Northeast Quarter to the point of beginning of the tract of land to be described; thence continuing North 89 degrees 38 minutes 37 seconds West 569.35 feet along said North line to the centerline of County Road No. 173, thence South 58 degrees 33 minutes 34 seconds West 50.00 feet along said centerline; thence South 31 degrees 26 minutes 26 seconds East 300.00 feet; thence North 58 degrees 33 minutes 34 seconds East 533.91 feet DISTRICT I to the point of beginning.
