JOINT RESOLUTION 15-03-221-13

A JOINT RESOLUTION APPROVING THE SUBMISSION OF A 2013 LANGUAGE PRESERVATION—ESTHER MARTINEZ INITIATIVE GRANT APPLICATION TO THE ADMINISTRATION OF CHILDREN AND FAMILIES: ADMINISTRATON OF NATIVE AMERICANS

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive have established as a priority the improvement of the physical, social, and mental well-being of the Band's Communities; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive recognize the importance of revitalizing the Ojibwe language to preserve and promote the traditional teachings and cultural values of Mille Lacs Band Elders; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive fully supports the goal of the Esther Martinez Initiative to revitalize Native American languages through language and cultural immersion programs to ensure their survival and continuing vitality; and
- WHEREAS, if awarded, the Mille Lacs Band Assembly and Chief Executive supports the Department of Education's Ojibwe Language Program intention to allocate not more than \$185,000 of its operating budget to support the immersion project over the proposed three years of FY2014-2016; and
- WHEREAS, if awarded, the Mille Lacs Band Assembly and Chief Executive support the use of \$185,000 of its operating budget through FY2014-2016 by MLBO Ojibwe Language Program to meet the grant requirement of providing cost matching nonfederal funds in the amount of at least 20 percent of the proposed grant budget.
- NOW, THEREFORE, BE IT RESOLVED that the Mille Lacs Band Assembly and Chief Executive do hereby authorize and approve the submission of a proposal to the Administration of Native Americans for the 2013 Native American Language Preservation and Maintenance—Esther Martinez Initiative grant program.
