RESOLUTION 15-03-211-13

**A RESOLUTION AUTHORIZING A RESIDENTIAL LAND LEASE
WITH AN ATTACHED MORTGAGE FOR [REDACTED]
& [REDACTED] (Parcel 4-Tract #s:410T000182 &
410T000265)**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, [REDACTED] & [REDACTED] respectfully request a land lease for residential purposes; and

WHEREAS, the lease will be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows:

That part of Tract 410T000265 described as the E ½ SW ¼ SW ¼ NE ¼ and the W ½ W ½ SE ¼ SW ¼ NE ¼, and Tract 410T000182 described as the E 1/2 NW ¼ SW ¼ NE ¼ and the E ½ W ½ NW ¼ SW ¼ NE ¼ all in Section 2 Township 41 North, Range 17 West, 4th principal meridian, Pine County, MN further described as:

Commencing at the General Land Office brass cap monument marking the northeast corner of said Southwest Quarter of the Northeast Quarter; thence North 89 degrees 38 minutes 37 seconds West, assumed bearing 623.29 feet along the north line of said Southwest Quarter of the Northeast Quarter to the centerline of County Road No 173; thence South 58 degrees 33 minutes 34 seconds West 643.00 feet along said centerline; thence South 33 degrees 26 minutes 26 seconds East 485.00 feet; thence North 62 degrees 33 minutes 34 seconds East 33.18 feet to the point of beginning of the tract of land to be described, thence North 33 degrees 26 minutes 26 seconds West 100.00 feet; thence North 62 degrees 33 minutes 34 seconds East 200.00 feet; thence South 33 degrees 26 minutes 26 seconds East 300.00 feet; thence North 75 degrees 26 minutes 26 seconds West 297.26 feet to the point of beginning. As surveyed by Bruce Grivna, Licensed Surveyor # 17253 in Central Minnesota Surveying Inc., survey dated January 18, 1999. The lease site contains approximately 0.25 acres in Tract 410T000182 more or less and 0.70 acres in Tract 410T000265 more or less.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Laes Band Assembly hereby authorizes a land lease with an attached mortgage for the property described herein for residential purposes be issued to [REDACTED] & [REDACTED] [REDACTED] for a period of 25 years, renewable for an additional 25 years subject to the lease provisions, effective upon date of approval; and

BE IT FURTHER RESOLVED, that the lessees will utilize the land in conformity with the provisions of the lease within twelve (12) months of the effective date of the lease, and if all terms of the lease are not met, the land will revert to the Mille Laes Band of Ojibwe; and

BE IT FURTHER RESOLVED, that this lease shall be null and void should the lessees abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1st year anniversary of the effective date of the lease without the prior approval of the Band Assembly; and

BE IT FURTHER AND FINALLY RESOLVED, this will terminate any other residential lease agreement that may be in existence in the name of the lessees.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 7th day of May, 2013 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
