RESOLUTION 15-04-258-13

A RESOLUTION APPROVING THE CONTINUANCE OF THE GOVERNMENT OPERATIONS, GAMING REGULATORY AUTHORITY, HOUSING INITIATIVE AND THE CORPORATE COMMISSION FISCAL OPERATIONS UNTIL NOVEMBER 30, 2013.

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly has the authority to appropriate all Band revenue, regardless of source; and
- WHEREAS, 3 MLBSA § 18 requires that all fiscal operations under the jurisdiction of the Mille Lacs Band shall cease as of midnight of the last day of the fiscal year unless the Band Assembly adopts a continuing resolution prior to such time; and
- WHEREAS, Band Assembly Appropriation Bill 15-01-45-12, to fund the operations of the Band Government for Fiscal Years 2012 and 2013, expires September 30, 2013; and
- WHEREAS, Band Assembly Appropriation Bill 15-03-20-13, to fund the operations of the Corporate Commission for Fiscal Year 2013, expires September 30, 2013; and
- WHEREAS, Band Assembly Appropriation Bill 15-01-46-12, to fund the operations of the Gaming Regulatory Authority for Fiscal Years 2012 and 2013, expires September 30, 2013; and
- WHEREAS, Band Assembly Appropriation Bill 15-02-15-13, to fund the operations of the Housing Initiative for Fiscal Year 2013, expires September 30, 2013.
- NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance of the Government Operations, Gaming Regulatory Authority, Housing Initiative and the Corporate Commission Fiscal operations until November 30, 2013.
