RESOLUTION 15-04-21-14

A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED BY RESOLUTIONS # 14-81 & 03-27-85 FOR [REDACTED]

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolutions #14-81 & 03-27-85, authorized a lease to be given to [REDACTED] for the purpose of obtaining a leasesite; and

WHEREAS, the land lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows:

Part of Tract 410 T 1002 located in the North ½ of the Northeast ¼ quarter of Section Twenty-eight (28), Township Forty-three North (43N), Range Twenty-seven West (27W) Mille Lacs County, Fourth Principal Meridian.

More particularly described as follows: Beginning at the S.W. Corner of the north 1/2 of the N.E. quarter, thence north 629,53 feet, thence east 1400 feet, thence south 13 feet, to point of beginning, thence south 200 feet, thence east 100 feet, thence north 168 feet, thence northwesterly running parallel with road to point of beginning, in section 28 township 43N range 27W.

WHEREAS, [REDACTED] is deceased and [REDACTED] no longer resides at the described property above; and

WHEREAS, [REDACTED] and the Minnesota Chippewa Tribe entered into a Lease Assignment Agreement; and

WHEREAS, the Mille Lacs Band Housing Department formerly known as the Mille Lacs Reservation Housing Authority purchased the home from the Minnesota Chippewa Tribe.
