## JOINT RESOLUTION 16-02-159-14

## A JOINT RESOLUTION APPROVING 2014 MEMBERSHIP INTO THE NATIONAL CONGRESS OF AMERICAN INDIANS (NCAI)

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, the Band wishes to remain a Member Tribe in good standing of the National Congress of American Indians (NCAI); and
- WHEREAS, the Band meets all requirements for Tribal Membership pursuant to Article II, Section 1(b) of the Constitution of the National Congress of American Indians.
- NOW, THEREFORE BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes Melanie Benjamin, Chief Executive of the Band, to take the necessary action to place the Band in membership in NCAI; and
- BE IT FURTHER RESOLVED, that tribal funds in the amount of \$25,000.00 (twenty-five thousand dollars) based on the Tribal Membership dues schedule of the NCAI bylaws, Article III, Section 1(b), are authorized to be paid for such Tribal Membership in NCAI; and
- BE IT FURTHER RESOLVED, that based on membership of 4,495 persons, as verified by the records of the Mille Lacs Tribal Enrollments Office, the Band shall have 140 votes in accordance with Article IV, Section 3 of the NCAI Constitution; and
- BE IT FURTHER AND FINALLY RESOLVED, that pursuant to Article V, Section 2, of the NCAI Constitution the Band designates the following named persons as Delegate and Alternate Delegates, and instructs them to become individual Members in good Standing in NCAI in order to fulfill their responsibilities as Official delegates to the National Congress of American Indians.
