RESOLUTION 16-02-143-14

**A RESOLUTION RESCINDING RESOLUTION # 14-03-06-11
AUTHORIZING A RESIDENTIAL LAND LEASE WITH AN ATTACHED
MORTGAGE TO [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and

WHEREAS, Resolution #14-03-06-11, authorized a land lease for residential purposes to be given to [REDACTED] for establishing her home with financing obtained from the Mille Lacs Band of Ojibwe Housing Department; and

WHEREAS, the residential lease was to be for a period of 35 years and renewable for an additional 15 years, and is subject to the lease provisions, effective February 2, 2011; and

WHEREAS, said land is described as follows:
A part of Tract # 410 T 1002, located in the North one-half (N ½) of the Northeast one-quarter (NE ¼) of Section Twenty-eight (28), Township Forty-three North (T43N), Range Twenty-seven North (R27N), Fourth Principal Meridian, Mille Lacs County, Minnesota, described as follows:
Lot Seven (7), Block One (1), Vineland Hills Plat dated March 9, 1982 by Anthony E. Kerrick registered surveyor # 12266

WHEREAS, [REDACTED] wishes to relinquish her leasesite.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the rescinding of Band Resolution #14-03-06-11; and

BE IT FURTHER AND FINALLY RESOLVED that the land will revert to the Mille Lacs Band of Ojibwe.


