JOINT RESOLUTION 16-02-145-14

A JOINT RESOLUTION APPROVING THE SUBMISSION OF A TRIBAL CHILD SUPPORT ENFORCEMENT GRANT TO THE UNITED STATES ADMINISTRATION AND FAMILIES: OFFICE OF CHILD SUPPORT ENFORCEMENT FOR FY2015

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive has established as a priority to improve the educational and social conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive recognize the importance of providing support for tribal children; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive fully support the goals of the Office of Child Support Enforcement; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive recognize that the Mille Lacs Band is required to commit cost sharing monies or in-kind resources order to receive funding in the amount of not more than \$145,688.95 which is 20% of the total program funding.

NOW, THEREFORE, BE IT RESOLVED that the Mille Lacs Band Assembly and Chief Executive do hereby authorize and approve the submission of an application to the United States Administration for Children and Families: Office of Child Support Enforcement for the purpose of obtaining grant funding to support tribal children.

WE DO HEREBY CERTIFY that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present, held on the 31st day of July, 2014 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
