**RESOLUTION 16-02-160-14**

**A RESOLUTION APPROVING THE CONTINUANCE OF PINE GROVE  
AND HOUSING INITIATIVE FISCAL OPERATIONS UNTIL  
DECEMBER 31, 2014**

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly has the authority to appropriate all Band revenue, regardless of source; and
- WHEREAS, 3 MLBSA § 18 requires that all fiscal operations under the jurisdiction of the Mille Lacs Band shall cease as of midnight on the last day of the fiscal year unless the Band Assembly adopts a continuing resolution prior to such time; and
- WHEREAS, the Pine Grove budget for fiscal year 2014 was approved by Ordinance 28-14, which lapse on September 30, 2014; and
- WHEREAS, the Housing Initiative budget for fiscal year 2014 was approved by Ordinance 12-14, which will lapse on September 30, 2014; and
- WHEREAS, the Band Assembly agrees to adopt a continuing resolution until December 31, 2014; and
- WHEREAS, until fiscal year 2015 budgets are approved for Pine Grove and Housing Initiative.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance fiscal operations for Pine Grove and Housing Initiative until December 31, 2014.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 30th day of September, 2014 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
