RESOLUTION 16-02-140-14

A RESOLUTION CANCELLING RESOLUTION # 13-02-45-08 WHICH AUTHORIZED A LAND LEASE FOR RESIDENTIAL PURPOSES TO THE MILLE LACS BAND HOUSING DEPARTMENT

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution #13-02-45-08 authorized a land lease to the Mille Lacs Band Housing Department for residential purposes; and

WHEREAS, the lease site was described as follows:
Tract 410TF000027, described as the South 100 feet of the West 200 feet of Lot 7, Johnston's Rearrangement. Located in Government Lot 4; Section Thirty-one (31), Township Forty-two North (42N), Range Twenty-six West (26W), Fourth Principal Meridian, Mille Lacs County, Minnesota, (Surveyed by Westwood Professional Services, dated 3/31/06, Job number 20065029SURV.DWG); and

WHEREAS, the lease site was part of the Mutual Help Program project; and

WHEREAS, the lease site was to be leased for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective July 17, 2008; and

WHEREAS, Cancellation of Resolution #13-02-45-08 is being requested by MLBHD because [REDACTED] has paid her Mutual Help Loan in full and the lease should be transferred into [REDACTED] name as a private ownership lease; and

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the cancellation of Resolution # 13-02-45-08.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 29th of July, 2014 at Vineland, Minnesota by a vote of ___FOR, ___AGAINST, ___SILENT.


