## **RESOLUTION 16-02-150-14**

## A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED BY RESOLUTION # 09-04-109-01 FOR

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 09-04-109-01, authorized a lease to be given to for the purpose of obtaining a leasesite; and

WHEREAS, the land lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows:

Part of Tract 410 TF 129 located in the Southeast one-quarter (SE ¼) of Section
Twenty (20), Township Forty-seven North (T47N), Range Twenty-three West
(R23W), Fourth Principal Meridian, Aitkin County, Minnesota more particularly
described as follows:

Commencing at a Global Positioning System (GPS) coordinate (479,220.64; 5,153,820.00) thence bearing South 0 degrees 22 minutes 28 seconds West 201.04 feet; thence North 90 degrees 0 minutes 0 seconds East 204.32 feet; thence North 0 degrees 11 minutes 25 seconds West 197.75 feet; thence North 89 degrees 4 minutes 12 seconds West 202.38 feet to the point of beginning GPS coordinate (479,220.64; 5,153,820.00). GPS coordinates are Universal Transverse Mercator (UTM) Zone 15 Nad 83 Projection Points. The leasesite is approximately 1 acre more or less; and

WHEREAS, location for his primary residency at the location described above.
