RESOLUTION 15-04-07-14

A RESOLUTION AUTHORIZING THE CORPORATE COMMISSION TO EXPEND FUNDS FROM 2014 CAPITAL BUDGET FOR THE REPLACEMENT OF POINT OF SALE (POS) SYSTEMS AT GRAND CASINO HINCKLEY AND GRAND CASINO MILLE LACS

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, the Band Assembly is authorized under 3 MLBSA sec. 2(b) to appropriate all Band revenue regardless of source; and

WHEREAS, the Band Assembly is also authorized under 3 MLBSA sec. 2(d) to adopt resolutions to promote the general welfare of the people; and

WHEREAS, the Corporate Commissioner of Corporate Affairs formally requests approval to expend 2014 capital project funds to replace Point of Sale (POS) systems at Grand Casino Hinckley and Grand Casino Mille Lacs at a cost of \$592,000.00.

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Corporate Commission expenditure of \$592,000.00 from the 2014 Capital Budget to replace the Point of Sale (POS) systems at Grand Casino Hinckley and Grand Casino Mille Lacs.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 22nd day of October, 2013 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
