**RESOLUTION 16-01-113-14**

**A RESOLUTION AUTHORIZING THE CORPORATE COMMISSION  
TO EXPEND FUNDS FROM 2014 CAPITAL BUDGET FOR UMT 360  
MICROSOFT PROJECT SOFTWARE AT BOTH GRAND CASINO  
HINCKLEY AND MILLE LACS PROPERTIES.**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, the Band Assembly is authorized under 3 MLBSA sec. 2(b) to appropriate all Band revenue regardless of source; and

WHEREAS, the Band Assembly is also authorized under 3 MLBSA sec. 2(d) to adopt resolutions to promote the general welfare of the people; and

WHEREAS, the Commissioner of Corporate Affairs formally request approval to expend 2014 capital project funds to purchase the UMT 360 product for both Grand Casino Mille Lacs and Grand Casino Hinckley properties in the amount of \$310,000.00.

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approve the Corporate Commission expenditure listed hereinabove from the 2014 Capital Budget.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 29<sup>th</sup> day of May, 2014 at Hinckley, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
