**A RESOLUTION IN SUPPORT OF THE UNIVERSITY OF MINNESOTA  
CENTER OF AMERICAN INDIAN AND MINORITY HEALTH  
APPLICATION TO THE INDIAN HEALTH SERVICE 2014 TO  
CONTINUE INMED ACTIVITIES**

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Mille Lacs Band Assembly have established as a priority the improvement of the physical, social, and mental well-being of the people of the Mille Lacs Band; and
- WHEREAS, the Center of American Indian and Minority Health, University of Minnesota – Duluth School of Medicine has been successful in supporting and guiding American Indian pre-health students through their program titled “University of Minnesota Indians into Medicine (INMED);” and
- WHEREAS, since 1973, the University of Minnesota Medical School has provided program activities that promoted, strengthened, and enhanced American Indian students’ interest and potential to pursue a career in medicine or health professions at the K-12, college, and professional student levels; and
- WHEREAS, the University of Minnesota Indians into Medicine program offers its activities to all tribes in a three state target area which includes: Wisconsin, Michigan and Minnesota.
- NOW, THEREFORE, BE IT RESOLVED that the Mille Lacs Band of Ojibwe does support the Center of American Indians and Minority Health’s application to the Indian Health Service in 2014 to continue INMED activities; and
- BE IT FURTHER AND FINALLY RESOLVED, that the Mille Lacs Band of Ojibwe does support the efforts of the Center of American Indian and Minority Health to guide and support American Indians pre-health students and recognizes their collaboration with American Indian communities in creating appropriate and culturally sensitive learning activities.


