RESOLUTION 15-04-20-14


A RESOLUTION APPROVING THE CONTINUANCE OF HOUSING INITIATIVE FOR THE FISCAL OPERATIONS UNTIL DECEMBER 31, 2013.

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly has the authority to appropriate all Band revenue, regardless of source; and
- WHEREAS, 3 MLBSA § 18 requires that all fiscal operations under the jurisdiction of the Mille Lacs Band shall cease as of midnight of the last day of the fiscal year unless the Band Assembly adopts a continuing resolution prior to such time; and
- WHEREAS, Band Assembly Appropriation Bill 15-02-15-13, to fund the operations of the Housing Initiative for Fiscal Year 2013, expires September 30, 2013; and
- WHEREAS, a continuing Resolution 15-04-258-13 expires on November 30, 2013, due to Fiscal Year 2014 budgets have not been approved for Housing Initiative; and
- WHEREAS, the Band Assembly feels it necessary to adopt a second continuing Resolution to extending the date to December 31, 2013.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance of the Housing Initiative for the Fiscal operations until December 31, 2013.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 27th day of November, 2013 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
