JOINT RESOLUTION 16-01-59-14

A JOINT RESOLUTION APPROVING THE SUBMISSION OF AN APPLICATION TO THE STATE OF MINNESOTA INDIAN AFFAIRS COUNCIL FY2014-2015 DAKOTA AND OJIBWE LANGUAGE IMMERSION PROGRAMMING GRANT TO ENHANCE OJIBWE LANGUAGE PROFICIENCY FOR TEACHER TRAINEES

WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, the Mille Lacs Band Assembly has established as a priority to improve the educational and social conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and

WHEREAS, the Mille Lacs Band Assembly recognizes the importance of providing computer access to low income families; and

WHEREAS, the Mille Lacs Band of Ojibwe fully endorses the initiative to provide complete immersion to teacher trainees of the Mille Lacs Band of Ojibwe residing on or near the reservation, and

WHEREAS, the Mille Lacs Band Assembly and Chief Executive recognize that the Mille Lacs Band is not required to commit cost sharing.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly does hereby authorize and approve the submission of a grant to the State of Minnesota Indian Affairs Council for the purpose of providing Ojibwe immersion to teacher trainees of the Mille Lacs Band of Ojibwe.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 30th day of January, 2014 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
