RESOLUTION 16-01-79-14

**A RESOLUTION CANCELLING A LEASE AUTHORIZED BY
RESOLUTION # 11-01-69-04 FOR A LAND LEASE TO [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution #11-01-69-04, authorized a lease to be given to [REDACTED] for the purpose of residential home site; and

WHEREAS, the lease was for a period of 35 years plus 15 years renewal, subject to the lease provisions, effective upon June 16, 2004, for the property described herein; and

WHEREAS, said land is described as follows:

Part of Tract 410 T 1001 located in the North one-half (N ½) of the Northeast One-quarter (NE ¼) of Section Twenty (20), Township Forty-three North (T43N) Range Twenty-seven West, (R27W) Mille Lacs County, Fourth Principal Meridian, more particularly described as follows:

Lot Thirty (30), Bugg Hill Plat. The lease site is approximately 1 acre more or less; and

WHEREAS, [REDACTED] has signed a Lease Cancellation for the lease site identified above due to violation of lease provisions #3, #18 & #19.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the lease cancellation authorized by Resolution #11-01-69-04; and

BE IT FURTHER RESOLVED, the land will revert to the Mille Lacs Band of Ojibwe.


