RESOLUTION 15-04-25-14

A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED BY RESOLUTION #07-03-82-97 FOR [REDACTED]

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution #07-03-82-97, authorized a lease to be given to [REDACTED] for the purpose of obtaining a leasesite; and

WHEREAS, the land lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows:

Part of Tract 410TF000058, the East 396.50 feet of the North Half of the following described tract: That part of the Northeast Quarter of the Southeast Quarter of Section 12, Township 42 North, Range 25 West, Mille Lacs County, Minnesota. Fourth Principal Meridian; described as follows: Beginning at the northeast corner of the Northeast Quarter of the Southeast Quarter; thence South 651.75 feet; thence West 733.35 feet; thence North 651.75 feet; thence East 733.35 feet to the point of beginning, known as Tract D.

Subject to and together with an easement for ingress and egress purposes over, under and across the North 16:50 feet of the East 733.35 feet of the Northeast Quarter of the Southeast Quarter of Section 12, Township 42, Range 25. This lease site is 1 acre more or less.

WHEREAS, the lease was never completed and the resolution did not authorize a mortgage to be attached to the leasehold interest.


