RESOLUTION 16-02-139-14

A RESOLUTION CANCELLING RESOLUTION # 11-01-59-04 AUTHORIZING A RESIDENTIAL LAND LEASE WITH AN ATTACHED MORTGAGE TO

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and

WHEREAS, Resolution #11-01-59-04, authorized a land lease for residential purposes to be given to obtained from the Mille Lacs Band of Ojibwe Housing Department; and

WHEREAS, the residential lease was to be for a period of 35 years and renewable for an additional 15 years, and is subject to the lease provisions, effective June 16, 2004; and

WHEREAS, said land is described as follows:

Part of Tract # 410 TF 204, located in the Southeast Quarter of the Northeast Quarter (SE ¼ of NE 1/4) of Section Four (4), Township Forty-one (T41), Range Seventeen (R17), Fourth Principal Meridian Pine County, Minnesota described as follows:

Beginning at the southwest corner of said SE ¼ of NE ¼; thence on an assumed bearing of south 89 degrees 55 minutes 02 seconds East along the South line of said SE ¼ of NE ¼ a distance of 352.0 feet; thence North 0 degrees 09 minutes 55 seconds West parallel with the West line of said SE ¼ of NE ¼ a distance of 100.00 feet; thence North 45 degrees 00 minutes 20 seconds West 233.95 feet to the southerly line of Grouse Trail in the recorded plat of Wilderness Estates 1st Addition; thence South 54 degrees West along said southerly line 190.0 feet to the East line of Razor Road in the recorded plat of Wilderness Estates 1st Addition; thence South 11 degrees 59 minutes 40 seconds West along said East line 156.64 feet to the point of beginning.
