RESOLUTION 16-02-153-14

A RESOLUTION RESCINDING RESOLUTION # 15-04-13-14 AUTHORIZING A RESIDENTIAL LAND LEASE TO

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and
- WHEREAS, Resolution #15-04-13-14, authorized a residential land lease to be given to and
- WHEREAS, the residential lease was to be for a period of 25 years and renewable for an additional 25 years, and is subject to the lease provisions, effective upon date of approval; and
- WHEREAS, said land is described as follows:

 That part of Tract 410T001002 located in the North half of the Northeast Quarter of Section Twenty-eight (28), Township Forty-three North (43N), Range Twenty-Seven West (27W), Mille Lacs County, Minnesota. Fourth Principal Meridian,

Further described as:

Lot Twelve (12), Block Four (4), Vineland Hills. Surveyed by Okerman Surveying Inc., June 24, 1983 registered land surveyor Robert W. Murray. The lease site is approximately ½ acre more or less.

- WHEREAS, the Lessee requests to rescind Resolution # 15-04-13-14, because she has been approved for a home loan with the Mille Lacs Band Housing Department and is requesting a new land lease.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves rescinding Band Resolution #15-04-13-14; and
- BE IT FURTHER AND FINALLY RESOLVED that the land will revert to the Mille Lacs Band of Ojibwe.
