RESOLUTION 15-04-24-14

**A RESOLUTION AUTHORIZING THE CORPORATE COMMISSION
TO EXPEND FUNDS FROM 2014 CAPITAL BUDGET**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, the Band Assembly is authorized under 3 MLBSA sec. 2(b) to appropriate all Band revenue regardless of source; and

WHEREAS, the Band Assembly is also authorized under 3 MLBSA sec. 2(d) to adopt resolutions to promote the general welfare of the people; and


WHEREAS, the Corporate Commissioner of Corporate Affairs formally requests approval to expend 2014 capital project funds for the following:

1. WMS Blade Slot machine for GCML at a cost of \$338,000.00;
2. EIFS repair at GCML East Wing at a cost of \$500,000.00;
3. HVAC upgrade for GCML at a cost of \$500,000.00; and
4. Wetlands Mitigation/Storm Water Management for GCML at a cost of \$750,000.00.
5. Konami Slot machine for GCML at a cost of \$333,735.00

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Corporate Commission expenditures listed hereinabove from the 2014 Capital Budget for Grand Casino Mille Lacs.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 12th day of December, 2013 at Isle, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
