RESOLUTION 15-04-29-14

A RESOLUTION MODIFYING RESOLUTION # 13-02-06-09 WHICH AUTHORIZED A LAND LEASE WITH AN ATTACHED MORTGAGE TO [REDACTED] & [REDACTED]

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution # 13-02-06-09 authorized a land lease with an attached mortgage to [REDACTED] for the purpose of establishing a home site; and

WHEREAS, the lease is for a period of 35 years and renewable for an additional 15 years, subject to the lease provisions, effective October 30, 2008 for the property described herein; and

WHEREAS, [REDACTED] is requesting her name be removed from Resolution #13-02-06-09 and lease # 4103690843; and

WHEREAS, Land description is described as follows:
Part of Tract # 410 TF 108, located in the North half of the Northwest Quarter (N1/2NW1/4) of Section Twenty (20), Township Forty-three North (43N), Range Twenty-seven West (27W), Fourth Principal Meridian, Mille Lacs County, Minnesota, described as follows:

Lot One (1) Block One (1) of Bugg Hill West Plat.

WHEREAS, removal of [REDACTED] name from Resolution # 13-02-06-09 and lease #4103690843 is being requested based on the Court Order of dissolution of marriage for [REDACTED] giving sole ownership of the leasehold interest to [REDACTED] and


