**RESOLUTION 15-04-30-14**

**A RESOLUTION APPROVING THE CONTINUANCE OF THE FISCAL OPERATIONS FOR THE CORPORATE COMMISSION, PINE GROVE LEARNING CENTER AND PROPOSED TRIBAL COLLEGE UNTIL MARCH 31, 2014.**

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly has the authority to appropriate all Band revenue, regardless of source; and
- WHEREAS, 3 MLBSA § 18 requires that all fiscal operations under the jurisdiction of the Mille Lacs Band shall cease as of midnight of the last day of the fiscal year unless the Band Assembly adopts a continuing resolution prior to such time; and
- WHEREAS, Band Assembly Appropriation Bill 15-03-20-13 funding operations of the Corporate Commission for Fiscal Year 2013 expired on September 30, 2013; and
- WHEREAS, on September 19, 2013, Continuing Resolution 15-04-258-13 was approved which expires on November 30, 2013; and
- WHEREAS, on November 26, 2013, Continuing Resolution 15-04-19-14 was approved which expires on December 31, 2013; and
- WHEREAS, Fiscal Year 2014 budgets are not approved as of this date for the Corporate Commission, Pine Grove Learning Center and proposed Tribal College and it is necessary to adopt a third Continuing Resolution to extend the date to March 31, 2014.

**NOW, THEREFORE, BE IT RESOLVED**, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance of Fiscal Operations of the Corporate Commission, Pine Grove Learning Center and proposed Tribal College until March 31, 2014.

**WE DO HEREBY CERTIFY**, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 23rd day of December, 2013 at Vineland, Minnesota by a vote of  3 FOR,  0 AGAINST,  0 SILENT.
