RESOLUTION 16-02-141-14

A RESOLUTION RESCINDING RESOLUTION # 15-02-13-13 AUTHORIZING A RESIDENTIAL LAND LEASE TO AND AS CO-LESSEES

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and
- WHEREAS, Resolution #15-02-13-13, authorized a residential land lease to be given to as Co-lessees; and
- WHEREAS, the residential lease was to be for a period of 25 years and renewable for an additional 25 years, and is subject to the lease provisions, effective upon date of approval; and
- WHEREAS, said land is described as follows:

 The West 200 feet of Lot 7, Johnston's Rearrangement of Government Lot 4,

 Section 3 1, Township 42 North, Range 26 West, Mille Lacs County, State of

 Minnesota. Except the South 100 feet thereof.

Subject to a 20 foot wide easement for ingress and egress over and across part of said Lot 7, Johnston's Rearrangement of Government Lot 4, the centerline of said easement being described as follows:

Commencing at the Northwest comer of said Lot 7; thence South 0 degrees 13 minutes 42 seconds West, assumed bearing, 13 5.63 feet along the West line of said Lot 7 to the point of beginning of said centerline to be described; thence North 30 degrees 26 minutes 45 seconds East 22.76 feet; thence North 56 degrees 25 minutes 38 seconds East 57.20 feet; thence North 68 degrees 11 minutes 50 seconds East 152.12 feet to the East line of the West 200 feet of said Lot 7 and said center line there terminating. The sidelines of said easement are to be prolonged or shortened at the West line of said Lot 7 and the East line of said West 200 feet of said Lot 7.

BE IT FURTHER RESOLVED, that the land will revert to the Mille Lacs Band of Ojibwe.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 29th of July, 2014 at Vineland, Minnesota by a vote of 2 FOR, AGAINST, SILENT.
