**RESOLUTION 16-02-13-15**

**A RESOLUTION MODIFYING RESOLUTION #16-01-122-14 WHICH  
AUTHORIZED LAND LEASE FOR RESIDENTIAL PURPOSES TO**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution #16-01-122-14 authorized a lease to be given to ██████████, ██████████ to the subject property for the purpose of establishing a home-site; and

WHEREAS, the legal description needs to be modified to reflect the correct the lease site location; and

WHEREAS, the lease site was described as Part of Tract 410T000116 located in the West one half of the Southeast one Quarter of the Southwest one Quarter of the Southeast one Quarter (W1/2SE1/4SW1/4SE1/4) of Section Seventeen (17), Township Forty-three North (T43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota.

More particularly described as Follows: Lot Four (4), Bugg Hill Trailer Park Plat; and

WHEREAS, the lease site should be described as follows:  
Part of Tract 410T000116 located in the West one half of the Southeast one Quarter of the Southwest one Quarter of the Southeast one Quarter (W1/2SE1/4SW1/4SE1/4) of Section Seventeen (17), Township Forty-three North (T43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota.

More particularly described as Follows: Lot Nine (9), Bugg Hill Trailer Park Plat.


NOW, THEREFORE, BE IT RESOVLED, that the lessee will utilize the land in conformity with the provisions of the lease within twelve (12) months of the effective date of the lease, and if all terms of the lease are not met, the land will revert to the Mille Lacs Band of Ojibwe; and

BE IT FURTHER RESOLVED, that the Mille Lacs Band Assembly hereby authorizes modification of the legal description for the lease site location described above for [REDACTED], [REDACTED] and all other terms and conditions shall remain the same and the only change will be the new lease site; and

BE IT FURTHER AND FINALLY RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1<sup>st</sup> year anniversary of the effective date of the lease without the prior approval of the Band Assembly.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 14th of November, 2014 at Isle, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
