RESOLUTION 16-02-22-15

**A RESOLUTION APPROVING THE CONTINUANCE OF THE
CORPORATE COMMISSION FISCAL OPERATIONS UNTIL
FEBRUARY 28, 2015**

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly has the authority to appropriate all Band revenue, regardless of source; and
- WHEREAS, 3 MLBSA § 18 requires that all fiscal operations under the jurisdiction of the Mille Lacs Band shall cease as of midnight on the last day of the fiscal year unless the Band Assembly adopts a continuing resolution prior to such time; and
- WHEREAS, Band Assembly Ordinance 08-14, to fund the operations of the Corporate Commission for Fiscal Year 2014, expired September 30, 2014; and
- WHEREAS, On September 23, 2014 Band Assembly adopted a continuing resolution 16-02-157-14 until December 31, 2014; and
- WHEREAS, Band Assembly agrees that a second continuing resolution is needed until February 28, 2015.
- NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance of the Corporate Commission fiscal operations until February 28, 2015.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 11th day of December, 2014 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
