RESOLUTION 16-03-41-15

**A RESOLUTION APPROVING THE CONTINUANCE OF HOUSING
INITIATIVE FISCAL OPERATIONS UNTIL APRIL 30, 2015**

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly has the authority to appropriate all Band revenue, regardless of source; and
- WHEREAS, 3 MLBSA § 18 requires that all fiscal operations under the jurisdiction of the Mille Lacs Band shall cease as of midnight on the last day of the fiscal year unless the Band Assembly adopts a continuing resolution prior to such time; and
- WHEREAS, the Housing Initiative budget for Fiscal Year 2014 was approved by the Band Assembly in Ordinance 12-14, which expired on September 30, 2014; and
- WHEREAS, Band Assembly adopted Resolution 16-02-160-14 for Housing Initiative to continue to operate until December 31, 2014, and a second Resolution 16-02-23-15 to continue to operate until February 28, 2015, since a Fiscal Year 2015 budget has not been approved; and
- WHEREAS, Band Assembly agrees that a third continuing resolution is needed until a Fiscal Year 2015 budget is approved.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance of the Housing Initiative fiscal operations until April 30, 2015.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 26th day of February, 2015 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
