**RESOLUTION 16-04-99-15**

**A RESOLUTION TO MODIFY RESOLUTION #28-83 WHICH  
AUTHORIZED LAND LEASES FOR MILLE LACS RESERVATION  
HOUSING AUTHORITY**

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,
- WHEREAS, Resolution #28-83, authorized a land lease to the Mille Lacs Reservation Housing Authority now known as the Mille Lacs band Housing Department for the purpose of home sites; and,
- WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective June 29, 1983 for the property described herein;
- WHEREAS, said land is described as follows:  
Part of Tract # 410 T 1002 described as Lot 16, Block 4, Vineland Hills, being part of the North Half of the Northeast Quarter of Section 28, Township 43 North, Range 27 West of the 4<sup>th</sup> Principal Meridian. Surveyed by Okerman Surveying, Inc. June 24, 1983 registered land surveyor Robert W. Murray.
- WHEREAS, Removal of the following land descriptions is requested from Resolution #28-83:  
Part of Tract # 410 T 1002 described as Lot 16, Block 4, Vineland Hills, being part of the North Half of the Northeast Quarter of Section 28, Township 43 North, Range 27 West of the 4<sup>th</sup> Principal Meridian. Surveyed by Okerman Surveying, Inc. June 24, 1983 registered land surveyor Robert W. Murray.  
and,
- WHEREAS, the above lease description was subleased to Band Member [REDACTED] under Mutual Help and Occupancy Agreements (HUD) with the Mille Lacs Band Housing Department; and,
- WHEREAS, Band Member [REDACTED] has satisfied her mortgage with the Mille Lacs Band of Ojibwe Housing Department and the lease description listed above should be removed from Resolution #28-83; and,
