A RESOLUTION AUTHORIZING A CONSTRUCTION EASEMENT FOR ROADS CONSTRUCTION ADJACENT TO THE MILLE LACS BAND DISTRICT 1 CEREMONIAL BUILDING

the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band WHEREAS. of Ojibwe, a federally-recognized Indian Tribe; and,

the Bureau of Indian affairs requires the granting of a temporary construction easement in WHEREAS. order to authorize road construction on Mille Lacs Band of Ojibwe tracts; and,

the temporary construction easement for the purposes of authorizing road construction is WHEREAS, to be conveyed to the MLB Public Works Department across the following tract:

> A part of Tract #410T000033 described as the West one half of the Northeast one quarter of the Southeast one quarter of the Northeast one quarter (W1/2NE1/4SE1/4NE1/4) of Section Twenty Eight, Township Forty-three North, Range Twenty-seven West. 4th principal meridian; containing 5 acres more or less; and,

the Mille Lacs Band of Ojibwe has determined that the overall benefits of the temporary WHEREAS. construction easement off sets any of the compensation benefits for the temporary construction easement; and,

the Mille Lacs Band Public Works Department will retain control and jurisdiction of said WHEREAS, Easement and temporary construction easement and

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby grants a temporary construction easement for improving a tribally owned public road and parking lot on the above tract of land.

BE IT FURTHER RESOVLED, the Mille Lacs Band hereby waives compensation for granting the temporary easement.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a of legislators being quorum present held on the 4th day of June, 2015 at Vineland, Minnesota by a vote of 3FOR, OAGAINST, SILENT.
