RESOLUTION 16-02-27-15

A RESOLUTION MODIFYING RESOLUTIONS #05-04-11-94 & #06-01-92-94 WHICH AUTHORIZED LAND LEASES FOR RESIDENTIAL PURPOSES TO MILLE LACS RESERVATION HOUSING AUTHORITY FOR THE 18 HOME PROJECT

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution #06-01-92-94 modified Resolution #05-04-11-94 which authorized a land lease to the Mille Lacs Reservation Housing Authority for the purpose of establishing the 18-Home site project; and

WHEREAS, the lease included the lease site described below to be leased for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective May 24, 1994; and

WHEREAS, the Lease site is described as follows:

Lease Description 16 further described as follows:

Commencing at the W1/4 corner of said Section 18, Twp. 41N, Range 17W, Pine County, State of Minnesota. Being a found G.L.O. monument; thence North 1,316.56' (the SW corner of said Allotment 222), thence East 33', thence North 193' to the point of beginning, thence East 191', thence North 166', thence West 191', thence South 166' to the point of beginning.

WHEREAS, Removal of the lease site above from Resolutions #06-01-92-94 & 05-04-11-94 is being requested by MLBHD because [REDACTED] is in good standing with her mortgage and the period has passed for the retention agreement; and

WHEREAS, the home located on the lease site is a private home and the lease site should be under the name of the owner.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes modification of Resolutions # 06-01-92-94 & 05-04-11-94, by removing the legal description described above and all other terms and conditions shall remain the same.
