JOINT RESOLUTION 16-04-24-16

A JOINT RESOLUTION APPROVING THE SUBMISSION OF THE MILLE LACS BAND OF OJIBWE'S DISTRICT I SAFE ROUTES TO SCHOOL SIDEWALK PROJECT APPLICATION TO THE TRANSPORTATION ALTERNATIVES PROGRAM

WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and

WHEREAS, the Band Assembly and Chief Executive have established as a priority the improvement of the spiritual, physical, mental, social, and economic well-being of the people of the Mille Lacs Band; and

WHEREAS, the Band Assembly and Chief Executive fully support the priorities presented in the 2015-2018 Mille Lacs Band of Ojibwe Tribal Transportation Improvement Plan and ensure that the top priorities will be addressed within phases as funding becomes available; and

WHEREAS, the Band Assembly and Chief Executive recognize the need to improve safety in the Bands community's by ensuring opportunities to make walking and bicycling to school safer and more accessible for children, including those with disabilities; and

WHEREAS, the Band Assembly and Chief Executive recognize that the Band is required to commit cost sharing monies or in-kind resources in order to remain a highly qualified applicant in the amount of not more than \$60,000.00 which is 20% of the total program funding.

NOW, THEREFORE, BE IT RESOLVED that the Band Assembly and Chief Executive do hereby authorize and approve the submission of an application to the Transportation Alternatives Program for the Mille Lacs Band of Ojibwe's District I Safe Routes to School Sidewalk Project.

Attached is a proposed resolution for Band Assembly's consideration.

If approved, the resolution will support Community Development's application to the Transportation Alternatives Program, for the Mille Lacs Band of Ojibwe's District 1 Safe Routes to School Sidewalk Project. We are going to include a 20% match of \$60,000 with our current BIA Tribal Transportation Funds (IRR funds).

The grant application will provide funds for a sidewalk project that coincides with our approved Tribal Transportation Improvement Plan.

Community Development conducted community meetings which included a community survey that had each district identify their road safety needs.

District 1: Sidewalks along Oodena Dr and Virgo Rd near the community center and government center

District 2A: Improve the 90 degree curve connecting Chiminsing Drive to Moose Drive

District 2: Pedestrian routes along Highway 65 to the school and community center

District 3: No pedestrian safety issues were identified

The other issues identified will be addressed in future phases of improvement as funding becomes available.

Grant Name: Mille Lacs Band of Ojibwe's District 1 Safe Routes to School Sidewalk Project

Funding Proposal: \$300,000

Cost Share/Match: Match of 20% - \$60,000
