**A RESOLUTION CANCELLING RESOLUTION 11-02-25-05
AUTHORIZING A RESIDENTIAL LAND LEASE WITH AN ATTACHED
MORTGAGE TO MILLE LACS BAND MEMBER [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body for the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 11-02-25-05, authorized a land lease with an attached mortgage for residential purposes to Mille Lacs Band Member [REDACTED]; and

WHEREAS, financing was obtained using the Mille Lacs Band Home Loan Program; and

WHEREAS, the residential lease was to be for a period of 35 years and renewable for an additional 15 years, subject to the lease provisions, effective December 2, 2004; and

WHEREAS, said land is described as follows:
Part of Tract 410 T 1001 located in the North one-half (N ½) of the Northeast One-quarter (NE ¼) of Section Twenty (20), Township Forty-three North (T43N) Range Twenty-seven West, (R27W) Mille Lacs County, Fourth Principal Meridian, more particularly described as follows:

Lot Twenty (20), Bugg Hill Plat. The lease site is approximately 1 acre more or less; and

WHEREAS, the lessee is requesting cancellation of his lease as he is selling his home to the Band.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the cancellation of Resolution 11-02-25-05.

BE IT FURTHER AND FINALLY RESOLVED that the land will revert back to the Mille Lacs Band of Ojibwe for lease to another Band Member.
