**RESOLUTION 17-01-113-16**

**A RESOLUTION APPROVING THE CONTINUANCE OF THE MILLE LACS BAND GOVERNMENT, GAMING REGULATORY AUTHORITY, AND HOUSING INITIATIVE FISCAL OPERATIONS UNTIL AUGUST 31, 2016**

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected governing body for the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(b) and (d), the Band Assembly has the authority to appropriate all Band revenue regardless of source, and adopt resolutions; and
- WHEREAS, 3 MLBSA § 18 requires that all fiscal operations under the jurisdiction of the Band shall cease as of midnight on the last day of the biennium, unless the Band Assembly adopts a continuing resolution prior to such time; and
- WHEREAS, Band Appropriation Bill 15-04-09-14, to fund the operations of the Band Government for Fiscal Years 2014 and 2015 expired September 30, 2015; and
- WHEREAS, Band Appropriation Bill 15-04-11-14, to fund the operations of the Gaming Regulatory Authority for Fiscal Years 2014 and 2015, expired September 30, 2015; and
- WHEREAS, Band Appropriation Bill 16-03-18-15, to fund the operations of the Housing Initiative for Fiscal Year 2015, expired September 30, 2015; and
- WHEREAS, Band Assembly adopted 16-04-109-15, 16-04-08-16, 16-04-16-16, 16-04-19-16, 17-01-53-16, 17-01-91-16, and 17-01-109-16 for said programs to continue to operate until October 31, 2015, November 30, 2015, December 31, 2015, February 29, 2016, April 30, 2016, May 31, 2016, and June 30, 2016 respectively, since Fiscal Year 2016 budgets have not yet been approved; and
- WHEREAS, the Band Assembly agrees that an eighth continuing resolution is needed until Fiscal Year 2016 budgets are approved for said programs.


