JOINT RESOLUTION 17-01-108-16

A JOINT RESOLUTION APPROVING THE SUBMISSION OF A 21ST CENTURY COMMUNITY LEARNING CENTERS PROGRAM GRANT APPLICATION TO THE U.S. BUREAU OF INDIAN EDUCATION

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body of the Mille Lacs Band of Ojibwe ("Band") a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly and Chief Executive have established as a priority the improvement of spiritual, physical, mental, social and economic well being of the people of the Band; and
- WHEREAS, the Band Assembly and Chief Executive recognizes the importance of providing academic enrichment activities such as homework tutoring, cultural, developmental and recreational opportunities; and
- WHEREAS, the Band Assembly and Chief Executive fully support the goals of the 21st Century Community Learning Center's program by addressing academic, developmental, and social emotional issues that are affecting school performance; and
- WHEREAS, the Band Assembly and Chief Executive recognize that there are no cost sharing requirements with the submission.
- NOW, THEREFORE, BE IT RESOLVED that the Band Assembly and Chief Executive do hereby authorize and approve the submission of a proposal to the Bureau of

Indian Education for the 21st Century Community Learning Center's Program.
