RESOLUTION 17-01-59-16

**A RESOLUTION CANCELLING A LEASE AUTHORIZED BY
RESOLUTION 15-04-242-13 FOR A LAND LEASE TO THE MILLE LACS
BAND HOUSING DEPARTMENT (MLBHD)**

WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body for the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 15-04-242-13, authorized a lease to MLBHD for the purpose of residential home site; and

WHEREAS, the lease was for a period of 25 years plus 25 years renewal, subject to the lease provisions, effective upon August 1, 2013, for the property described herein; and

WHEREAS, said land is described as follows:
Part of Tract # 410T001001 located in the North one-half (N1/2) of the Northeast One-quarter (NE1.4) of Section Twenty (20), Township Forty-three (43N) North, Range Twenty-seven (27W) West, of the Fourth Principal Meridian, Mille Lacs County, Minnesota,

Further described as Lot Nine (9), Bugg Hill Plat. This lease site is 1 acres more or less; and

WHEREAS, the Lessee is requesting to cancel the lease authorized by Resolution 15-04-242-13 to make the site available to a band member to purchase the home and obtain a lease on the site.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the lease cancellation authorized by Resolution 15-04-242-13; and

BE IT FURTHER AND FINALLY RESOLVED, the land will revert to the Mille Lacs Band of Ojibwe.


