RESOLUTION 17-01-70-16

**A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED
BY RESOLUTION 08-01-87-98 AND MODIFIED BY RESOLUTION 08-03-
42-99 FOR MILLE LACS BAND MEMBER [REDACTED]**

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body for the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolutions 08-03-42-99 & 08-01-87-98, authorized a lease to be given to Mille Lacs Band Member [REDACTED] for the purpose of obtaining a leasesite; and
- WHEREAS, the land lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:
Part of Tract # 410TF000103, described as the East 200.00 feet of Lot 3, Block 2, Wilderness Estates 1st Addition, excluding therefrom the North 65.00 feet., together with a Non-exclusive access easement to Razor Lake over and across the following described premises: The South 800 feet of the North 1295 feet of that part of East ½ of the Southeast ¼ of Section 4, Township 41 North, Range 17 West lying West of Razor Lake and Easterly of the East right of way line of Razor Road according to the recorded plat of Wilderness Estates 1st Addition. Which easement is intended to provide access to Razor Lake for the owners of Lot 3, Block 2, Wilderness Estates 1st Addition. This site to be leased is approximately 1 acre more or less; and
- WHEREAS, Mille Lacs Band Member [REDACTED] is deceased (date of death July 13, 2007).

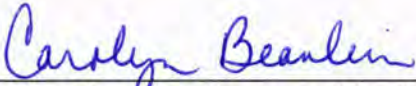
