RESOLUTION 17-01-73-16

**A RESOLUTION RESCINDING RESOLUTION 17-01-49-16
AUTHORIZING A RESIDENTIAL LAND LEASE WITH AN ATTACHED
MORTGAGE TO MILLE LACS BAND MEMBER [REDACTED]**

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body for the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 17-01-49-16, authorized a land lease for residential purposes to be given to Mille Lacs Band Member [REDACTED] for establishing his home with financing obtained from the Mille Lacs Band Housing Home Loan Program; and
- WHEREAS, the residential lease was to be for a period of 35 years and renewable for an additional 15 years, and is subject to the lease provisions, effective February 11, 2016; and
- WHEREAS, said land is described as follows:
Part of Tract # 410TF000311 located in Lot Two (2), Block One (1) in High Point First Addition, according to the plat thereof on file and of record in the office of the Registrar of Titles in and for said county; Fourth Principal Meridian, Crow Wing County, Minnesota; and
- WHEREAS, rescinding Resolution 17-01-49-16 is being requested by the lessee, he no longer wants the lease site described above.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Rescinding of Band Resolution 17-01-49-16; and
- BE IT FURTHER AND FINALLY RESOLVED, the land will revert to the Mille Lacs Band of Ojibwe.

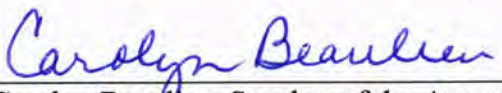
