## **RESOLUTION 17-01-92-16**

A RESOLUTION APPROVING THE CONTINUANCE OF MILLE LACS CORPORATE VENTURES, GAMING, AND NON-GAMING FISCAL OPERATIONS UNTIL MAY 31, 2016

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body for the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(b) and (d), the Band Assembly has the authority to appropriate all Band revenue regardless of source, and adopt resolutions; and
- WHEREAS, 3 MLBSA § 18 requires that all fiscal operations under the jurisdiction of the Band shall cease as of midnight on the last day of the biennium, unless the Band Assembly adopts a continuing resolution prior to such time; and
- WHEREAS, Band Appropriation Bills 16-03-28-15, 16-03-29-15, and 16-03-30-15 to fund the operations of Mille Lacs Corporate Ventures ("MLCV"), Non-Gaming, and Gaming respectively for Fiscal Year 2015, expired September 30, 2015; and
- WHEREAS, Band Assembly adopted 16-04-108-15, 16-04-20-16, and 17-01-54-16 for said operations to continue to operate until December 31, 2015, February 29, 2016, and April 30, 2016 respectively since Fiscal Year 2016 budgets have not been approved; and
- WHEREAS, the Band Assembly agrees to adopt a fourth continuing resolution until May 31, 2016.
- NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance of the MLCV, Non-Gaming, and Gaming fiscal operations until May 31, 2016.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 28th day of April, 2016 at Nayahshing, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
