**RESOLUTION 17-01-55-16**

**A RESOLUTION DESIGNATING THE COMMUNITY ROOM AT THE  
DISTRICT I COMMUNITY CENTER AS THE MILLE LACS BAND OF  
OJIBWE ELECTION OFFICE**

WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, the District Representative is empowered by 3 MLBSA §8 (a) (6), to authorize the use of district community centers according to written standards that are fair and reasonable; and

WHEREAS, the District I Representative agrees to authorize the use of the community room at the District I Community Center as the Election Office for the Mille Lacs Band of Ojibwe; and

WHEREAS, the Band Assembly agrees that the usage of the community room as the Election Office is a suitable site for the same.

NOW THEREFORE BE IT RESOLVED, the Band Assembly hereby approves the community room at the District I Community Center, effective immediately through the end of the 2016 Election cycle, as the Election Office for the Mille Lacs Band of Ojibwe.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 18<sup>th</sup> day of February, 2016 at Nayahshing, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
