RESOLUTION 17-03-47-17


A RESOLUTION APPROVING THE CONTINUANCE OF THE MILLE LACS BAND HOUSING INITIATIVE FISCAL OPERATIONS UNTIL MAY 31, 2017

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected governing body for the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(b) and (d), the Band Assembly has the authority to appropriate all Band revenue regardless of source, and adopt resolutions; and
- WHEREAS, 3 MLBSA § 18 requires that all fiscal operations under the jurisdiction of the Band shall cease as of midnight on the last day of the fiscal year, unless the Band Assembly adopts a continuing resolution prior to such time; and
- WHEREAS, Band Appropriation Bill 17-02-15-17 was passed on January 26, 2017 to fund the operations of Mille Lacs Band Housing Initiative with FY15 Carryover Funds for Fiscal Year 2016; and
- WHEREAS, Band Assembly agrees to adopt a continuing resolution until May 31, 2017 for said operations to continue to operate since Fiscal Year 2017 budgets have not been approved.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance of the Mille Lacs Band Housing Initiative fiscal operations until May 31, 2017.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 11th day of April, 2017 at Chi Minising, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
