JOINT RESOLUTION 17-02-07-17

A JOINT RESOLUTION IN SUPPORT OF THE APPOINTMENT OF GEORGETTE CHRISTENSEN TO THE MINNESOTA INDIAN CHILD WELFARE ADVISORY COUNCIL

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Minnesota Indian Child Welfare Advisory Council requires a resolution from the Mille Lacs Tribal government supporting the appointment of their Tribal representative to the Council; and
- WHEREAS, each Tribe in Minnesota has a seat on the Minnesota Indian Child Welfare Advisory Board; and
- WHEREAS, Georgette Christensen is employed as the Director of Family Services for the Mille Lacs Band of Ojibwe.
- NOW, THEREFORE, BE IT RESOLVED that the Band Assembly and Chief Executive hereby appoint Georgette Christensen to represent the Mille Lacs Band of Ojibwe on the Council; and
- BE IT FURTHER AND FINALLY RESOLVED that the Mille Lacs Band of Ojibwe Indians wholeheartedly supports and endorses Georgette Christensen as a member of the Minnesota Indian Child Welfare Advisory Council.
