RESOLUTION 17-03-62-17

A RESOLUTION APPROVING THE CONTINUANCE OF THE MILLE LACS BAND HOUSING INITIATIVE FISCAL OPERATIONS UNTIL JUNE 30, 2017

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected governing body for the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(b) and (d), the Band Assembly has the authority to appropriate all Band revenue regardless of source, and adopt resolutions; and
- WHEREAS, 3 MLBSA § 18 requires that all fiscal operations under the jurisdiction of the Band shall cease as of midnight on the last day of the biennium, unless the Band Assembly adopts a continuing resolution prior to such time; and
- WHEREAS, Band Appropriation Bill 17-02-15-17 was passed on January 26, 2017 to fund the operations of Mille Lacs Band Housing Initiative (“Housing Initiative”) with FY15 Carryover Funds for Fiscal Year 2016; and
- WHEREAS, Band Assembly adopted 17-03-47-17 for Housing Initiative to continue to operate until May 31, 2017 since the Fiscal Year 2017 budgets have not been submitted by the Commissioner of Community Development; and
- WHEREAS, the Band Assembly agrees to adopt a second continuing resolution to allow Housing Initiative to continue to operate until June 30, 2017, since Fiscal Year 2017 budgets have not yet been submitted by the Commissioner of Community Development.
- NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance of the Mille Lacs Band Housing Initiative fiscal operations until June 30, 2017.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 25th day of May, 2017 at Nayahshing, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
