## A RESOLUTION AUTHORIZING THE MILLE LACS CORPORATE VENTURES TO EXPEND FUNDS FROM 2017 CAPITAL BUDGET FOR **GRAND CASINO MILLE LACS SLOT MACHINE PURCHASES**

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly is authorized under 3 MLBSA sec. 2(b) to appropriate all Band revenue regardless of source; and
- the Band Assembly is also authorized under 3 MLBSA sec. 2(d) to adopt WHEREAS, resolutions to promote the general welfare of the people; and
- WHEREAS, the Commissioner of Corporate Affairs formally requested approval on November 21, 2016 to expend 2017 capital project funds for the slot machine purchases at Grand Casino Mille Lacs in the amount of \$2,285,700.00.
- NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Mille Lacs Corporate Ventures expenditure listed hereinabove from the 2017 Capital Budget.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 22nd day of November, 2016 at Nayahshing, Minnesota by a vote of  $\Im$ FOR,  $\bigcirc$  AGAINST,  $\bigcirc$  SILENT.
