**RESOLUTION 17-03-55-17**

**A RESOLUTION CANCELLING RESOLUTION 05-01-42-92  
AUTHORIZING A RESIDENTIAL LAND LEASE TO MILLE LACS  
BAND MEMBER [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 05-01-42-92 authorized a residential land lease to Mille Lacs Band Member [REDACTED]; and

WHEREAS, the lease was for a period of 25 years plus 25 years, effective April 29, 1992; and

WHEREAS, said land is described as follows:

Block 1, Lot 13, referred to on map as no. 96 in Vineland Hills.

NOW, THEREFORE, BE IT RESOLVED, that the lessee, Mille Lacs Band Member [REDACTED], wishes to cancel the land lease authorized by Resolution 05-01-42-92, approved on April 29, 1992; and

BE IT FURTHER RESOLVED, that the lessee has no interest in the property and requests cancellation of the land lease described above so the property can revert back to the Band.


