JOINT RESOLUTION 17-03-56-17

A JOINT RESOLUTION APPROVING THE ENROLLMENTS INTO THE MILLE LACS BAND, MILLE LACS RESERVATION FOR THOSE WHO MEET THE 1/4 DEGREE REQUIREMENT OF THE MINNESOTA CHIPPEWA TRIBE

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 6, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly and Chief Executive have reviewed the following applications for enrollment:



- NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly and Chief Executive approves the above applications for enrollment and approves all rights provided for Mille Lacs Band of Ojibwe, Minnesota Chippewa Tribe enrollees.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 25th day of May, 2017 at Nayahshing, Minnesota by a vote of 3 FOR, AGAINST, SILENT.
