RESOLUTION 17-03-60-17

**A RESOLUTION CANCELLING RESOLUTION 14-01-108-10
AUTHORIZING A RESIDENTIAL LAND LEASE TO MILLE LACS
BAND MEMBER [REDACTED]**

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 14-01-108-10 authorized a residential land lease with an attached mortgage to Band Member [REDACTED] for the purpose of obtaining a lease site; and
- WHEREAS, the land lease was to be for a period of 35 years and renewable for an additional 15 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:

Part of Tract 410 T 1001 located in the North One-half (N ½) of the Northeast One-quarter (NE ¼) of Section Twenty (20), Township Forty-three North (T43N), Range Twenty-seven West (R27W), Mille Lacs County, Minnesota. Fourth Principal Meridian, more particularly described as follows:

Lot Thirty-nine (39), Bugg Hill Plat. This lease site is approximately one (1) acre, more or less; and

- WHEREAS, the lessee voluntarily relinquishes her land lease authorized by tribal resolution 14-01-108-10 and requests this lease site revert back to the Band.


