**RESOLUTION 17-03-49-17**

**A RESOLUTION TO CANCEL A RESIDENTIAL LAND LEASE  
AUTHORIZED BY RESOLUTION 12-04-101-07 FOR MILLE LACS  
BAND MEMBER [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 12-04-101-07 authorized a residential land lease to Band Member [REDACTED] for the purpose of obtaining a lease site; and

WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows:

Tract 410 TF 220 described as Lot Fifty-two (52) & Fifty-three (53), Block Seven (7), Port Mille Lacs Golf Acres North, according to the filed plat thereof. Fourth Principal Meridian, Mille Lacs County, Minnesota. This lease site is 1 acre more or less.

WHEREAS, the lessee has chosen another lease site and requests this lease site be relinquished back to the Band.

NOW, THEREFORE, BE IT RESOLVED, the Band Assembly hereby approves the cancellation of Resolution 12-04-101-07; and

BE IT FURTHER AND FINALLY RESOLVED that the land will revert back to the Band.
