## **RESOLUTION 17-03-61-17**

A RESOLUTION APPROVING THE CONTINUANCE OF MILLE LACS CORPORATE VENTURES, NON-GAMING, AND GAMING FISCAL OPERATIONS UNTIL JULY 31, 2017

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body for the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(b) and (d), the Band Assembly has the authority to appropriate all Band revenue regardless of source, and adopt resolutions; and
- WHEREAS, 3 MLBSA § 18 requires that all fiscal operations under the jurisdiction of the Band shall cease as of midnight on the last day of the biennium, unless the Band Assembly adopts a continuing resolution prior to such time; and
- WHEREAS, Band Appropriation Bills 17-01-32-16, 17-01-33-16, and 17-01-34-16 to fund the operations of Mille Lacs Corporate Ventures ("MLCV"), Non-Gaming, and Gaming respectively for Fiscal Year 2016, expired September 30, 2016; and
- WHEREAS, Band Assembly adopted 17-02-08-17, 17-02-25-17, and 17-03-45-17 for said operations to continue to operate until December 31, 2016, March 31, 2017, and May 31, 2017 respectively; and
- WHEREAS, Band Assembly agrees to adopt a fourth continuing resolution for said operations to continue to operate until July 31, 2017 since Fiscal Year 2017 budgets have not been approved.
- NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance of the MLCV, Non-Gaming, and Gaming fiscal operations until July 31, 2017.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 25th day of May, 2017 at Nayahshing, Minnesota by a vote of 3 FOR, O AGAINST, O SILENT.
