**RESOLUTION 17-03-77-17**

**A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED  
BY RESOLUTION 12-02-22-07 FOR MILLE LACS BAND MEMBER**

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 12-02-22-07 authorized a residential land lease to Band Member [REDACTED] for the purpose of obtaining a lease site; and
- WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:
- Part of Tract 410T000116, located in the West Half of the Southeast Quarter of the Southwest Quarter of the Southeast Quarter (W ½- SE ¼- SW ¼-SE ¼) of Section Seventeen (17), Township Forty-three North (43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota.
- More particularly described as follows: Lot Three (3), Bugg Hill Trailer Park Plat, containing 1 acre more or less.
- WHEREAS, the lessee voluntarily relinquishes his land lease authorized by tribal resolution 12-02-22-07 and requests this lease site revert back to the Band.
