RESOLUTION 17-04-105-17

A RESOLUTION APPROVING THE CONTINUANCE OF THE MILLE LACS BAND GOVERNMENT, GAMING REGULATORY AUTHORITY, HOUSING INITIATIVE, AND ATHLETIC COMMISSION FISCAL OPERATIONS UNTIL DECEMBER 31, 2017

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected governing body for the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2(b) and (d), the Band Assembly has the authority to appropriate all Band revenue regardless of source, and adopt resolutions; and

WHEREAS, 3 MLBSA § 18 requires that all fiscal operations under the jurisdiction of the Band shall cease as of midnight on the last day of the biennium, unless the Band Assembly adopts a continuing resolution prior to such time; and

WHEREAS, Band Appropriation Bill 17-02-46-16, to fund the operations of the Band Government for Fiscal Years 2016 and 2017, expires September 30, 2017; and

WHEREAS, Band Appropriation Bill 17-04-43-17, to fund the operations of the Housing Initiative for Fiscal Year 2017, expires September 30, 2017; and

WHEREAS, Band Appropriation Bill 17-02-56-16, to fund the operation of the Athletic Commission for Fiscal Years 2016 and 2017, expires September 30, 2017; and

WHEREAS, the Band Assembly agrees to adopt a continuing resolution until December 31, 2017.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance of Band Government, Gaming Regulatory Authority, Housing Initiative, and Athletic Commission fiscal operations until December 31, 2017.
